Section 2 : **Product Composition (Classification)**

The subject formulation is a blend of carbohydrates, inorganic salts. Phenol red is included as a pH indicator. After preparation in purified water, all ingredients are in concentrations of less than 1%.

Section 3 : **Hazards Identification**

Hazard : Not classified as hazardous. No exposure limits established by OSHA or ACGIH.

Section 4 : **First - Aid Measures**

In case of swallowing, wash out mouth with water provided person is conscious. In case of skin contact, flush with copious amounts of water for at least 15 minutes.
