### Section 2 : Product Composition (Classification)

The subject formulation is a blend of carbohydrates, inorganic salts. Phenol red is included as a pH indicator. After preparation in purified water, all ingredients are in concentrations of less than 1%.

### Section 3 : Hazards Identification

#### Section 4 : First - Aid Measures
